Re: Request for Investigation into Representative Mariannette Miller-Meeks for Violations of Voting Laws and House Ethics Rules

Dear Mr. Ashmawy,

I respectfully request that the Office of Congressional Ethics (“*OCE*”) immediately investigate U.S. Representative Mariannette Miller-Meeks of Iowa’s 1st congressional district for her apparent violations of Iowa voting laws and U.S. House of Representatives Rules (“*House Rules*”), made by registering to vote and voting at addresses where she does not reside.

Voting eligibility laws are paramount to ensuring the integrity of the electoral process. Further, House Rules and ethical guidance exist to maintain decorum and the public’s faith in Congress. In cases like this, House Rule 23 (Code of Official Conduct) ensures that Members do not engage in violations of the law that would reflect poorly on the character and efficacy of Congress as a whole.¹

As OCE has jurisdiction to investigate violations of the Code of Official Conduct, as well as violations of “any applicable rules, laws, or regulations governing the performance of official duties or the discharge of official responsibilities” of Members,² I respectfully request that your office commence an immediate investigation into this matter to determine whether Representative Miller-Meeks has violated House Rules, guidance of the U.S. House of Representatives Committee on Ethics, and applicable state voting laws.

Given the impending general election, I request that OCE commence its investigation as soon as possible. *An expedient resolution should afford Representative Miller-Meeks the time necessary to correct any errors in her voter registration record before she attempts to vote in the 2024 general election in Iowa.*

I. Factual Background

U.S. Representative Mariannette Miller-Meeks was first elected to represent Iowa's 2nd congressional district on November 3, 2020.³ She won her election to represent Iowa's 1st congressional district on November 8, 2022.⁴ Now, in 2024, she is running for reelection to continue to represent Iowa's 1st congressional district. Miller-Meeks for Congress is her principal congressional campaign committee registered with the Federal Election Commission.⁵

a. Representative Miller-Meeks has been registered to vote in IA-01 (Scott County) since late 2022; previously, she was registered to vote in IA-03 (Wapello County).

According to voter registration records, Miller-Meeks is currently registered to vote at 3531 Jersey Ridge Road, Apt. 323, in Davenport, Iowa (the "*Davenport address*").⁶ Prior to being registered to vote at the Davenport address, and between October 2022 and at least May 2024, Miller-Meeks was registered to vote at 21931 Great River Road in LeClaire, Iowa (the "*LeClaire address*").⁷ Both of these addresses are in Scott County, which is within Iowa's 1st congressional district—the district that Miller-Meeks represents in Congress. Miller-Meeks appears to have voted while registered at the LeClaire address during the November 2022 general election.⁸ She also appears to have voted while registered at either the Davenport address or the LeClaire address⁹ during the June 2024 primary election.¹⁰

Prior to registering to vote at the LeClaire address in October 2022, Miller-Meeks was registered to vote at 11674 90th Street in Ottumwa, Iowa (the "*Ottumwa address*"). This address is in Wapello County, which is within Iowa's 3rd congressional district. Miller-Meeks appears to have voted in federal, state, and local elections in Wapello County since at least June 2012.¹¹ It appears that she last voted in Wapello County during the June 2022 primary election.¹² As noted above, following that election, she seems to have consistently voted in Scott County.

b. Public records strongly suggest that Representative Miller-Meeks likely resides in IA-03 (Wapello County) at the Ottumwa address, even though she is registered to vote in IA-01 (Scott County).

Multiple public records strongly suggest that Representative Miller-Meeks is not a resident for voter registration purposes of Scott County, Iowa, despite being registered to vote there. Instead, public records appear to indicate that Miller-Meeks should be registered in Wapello County, Iowa.

i. Property Ownership and Tax Records

According to property records, the Ottumwa address is the location of the six-bedroom home¹³ that Miller-Meeks currently owns with her husband, Curtis Meeks.¹⁴ Miller-Meeks and her husband originally purchased a 33-acre vacant lot at the Ottumwa address in March 2003.¹⁵ The couple constructed their home on the property around 2004.¹⁶ Curtis Meeks is currently registered to vote at the Ottumwa address, which is in Wapello County.¹⁷ The Ottumwa address is approximately 138 miles by car from the Davenport address in Scott County, where Miller-Meeks is registered to vote.¹⁸

Further, Miller-Meeks and Curtis Meeks' most recent property tax statement for the Ottumwa address indicates that the couple received a "homestead credit"¹⁹ on the property for the July 1, 2023 through June 30, 2024 tax period.²⁰ The couple appears to have received the same credit on the statement associated with the July 1, 2022 through June 30, 2023 tax period; they paid

applicable taxes for that period on August 15, 2023.²¹ As noted above, Miller-Meeks appears to have been registered to vote at the LeClaire address in Scott County (more than 100 miles from her Ottumwa home) at the time this property tax was paid.²²

ii. Financial Disclosure Reports

Miller-Meeks also seems to have indicated that the Ottumwa address is her home while making required financial disclosures. On the two most recent Financial Disclosure Reports that she filed with the Clerk of the House of Representatives (for the 2022 and 2023 reporting years), Miller-Meeks reported that she has a mortgage on her “*personal residence* in Ottumwa, IA.”²³ Presumably, this disclosure is referring to the property and home she owns at the Ottumwa address. Again, Miller-Meeks appears to have been registered to vote at the LeClaire address in Scott County at the time that she filed both of these disclosure reports.²⁴

iii. Political Contribution Records

Federal Election Commission records also indicate that Miller-Meeks lives in Ottumwa. Miller-Meeks appears to have last contributed to another federal congressional candidate from Iowa in December 2023.²⁵ Though she was registered to vote at the LeClaire address during this time, she reported her mailing address as the Ottumwa address for the purposes of the contribution.²⁶ It appears that Miller-Meeks consistently listed the Ottumwa address as her mailing address for the purposes of political contributions prior to 2023.²⁷

c. It seems unlikely that Miller-Meeks resides, or has recently resided, in IA-01, where she has been registered to vote for nearly two years.

In contrast with the Ottumwa address, the Davenport address (where Miller-Meeks is currently registered), is an apartment complex, where apartment sizes range from studios to three bedrooms.²⁸ In February 2024, in response to a question regarding where she lived, Miller-

Meeks told attendees at a listening session that she “ha[s] a home in Davenport.”²⁹ It is not clear that Miller-Meeks has any other connections to the city of Davenport, other than her current voter registration at the Davenport address.

Similarly, the LeClaire address (where Miller-Meeks was registered until at least May 2024), appears to be the location of the home of Christine Cournoyer,³⁰ who is a current Iowa State Senator³¹ and former colleague of Miller-Meeks.³² According to property records, the property at the LeClaire address has been owned by Cournoyer’s parents,³³ Burton and Marilyn Gearhart, since 2019.³⁴ The LeClaire address was listed as Cournoyer’s address on an official “Candidate List” for the 2022 general election.³⁵ On this *same* list, Miller-Meeks’ address was listed as the Ottumwa address.³⁶

It appears that Cournoyer currently remains registered to vote at the LeClaire address.³⁷ It is not clear that Miller-Meeks has any other connections to the city of LeClaire, other than her previous voter registration at the LeClaire address.

II. Legal Standards & Analysis

a. Iowa law requires Miller-Meeks to register to vote and to vote in the county and precinct where she resides.

According to Iowa law, voters must register to vote and vote in the county and precinct where they *reside*.³⁸ When someone registers to vote, they must sign a “Registration Affidavit” and attest to the fact that they “*live at the address listed*” on their voter registration form.³⁹ Under the law, a voter’s residence is “the place which the person declares is the person’s home with the intent to remain there permanently or for a definite, or indefinite or indeterminable length of time.”⁴⁰ A voter’s residence is also defined as the their “home or dwelling” and their “*primary nighttime residence*.”⁴¹ Thus, the law suggests that it is only possible for a voter to have *one* place of residence (*i.e.*, their primary home where they sleep at night) for the purposes of voter registration and voting.

Though Miller-Meeks has been registered to vote at various addresses in Scott County for nearly two years now, the facts presented above⁴² strongly suggest that her residence—the home where she *lives and the primary home where she sleeps at night*—is in Wapello County, where her husband lives and is registered to vote, and where she was registered to vote and regularly voted for at least a decade prior to her 2022 bid to represent the congressional district that encompasses Scott County. Given these facts, and the laws that require Iowa voters to register and vote using their residential address, Miller-Meeks should likely be registered to vote at the Ottumwa address. Thus, it appears she is violating Iowa voting law by remaining registered to vote and voting in a county and precinct where she does not reside.

b. House Rules require that Miller-Meeks act in a manner that reflects credibly on the institution of Congress, including by following the law.

If Miller-Meeks is reporting an incorrect address to the state of Iowa for voting purposes, she is also likely violating House Rules. House Rule 23 requires that Members “conduct [themselves] at all times in a manner that shall reflect creditably on the House.”⁴³ This rule is so fundamental to House ethics standards that it is laid out on page one of the House Ethics Manual.⁴⁴ The requirement of this rule is “comprehensive” and was included “to deal with ‘flagrant’ violations of the law that reflect on ‘Congress as a whole.’”⁴⁵

By disregarding the clear voter registration laws of the state that she represents in Congress, Miller-Meeks seems to be flouting the legal requirements that all of her constituents must abide by in order to participate in the electoral process. Indeed, Miller-Meeks herself has emphasized the importance of voter eligibility laws in her role as a Congresswoman.⁴⁶ However, the facts

presented in this complaint indicate that Miller-Meeks is not registered at an address where she is eligible to vote.

Such a violation of election laws by an elected representative seems to be exactly the type of conduct that Rule 23 is meant to discourage. Miller-Meeks' constituents—and the larger voting public—are entitled to expect that their representatives at the highest levels of government will follow the law, and this expectation is underscored by the Committee on Ethics' guidance surrounding this issue.

III. Request for Action

Again, I respectfully request that you commence an immediate investigation into this matter. Representative Miller-Meeks must not be permitted to remain registered to vote in a county and precinct if she does not reside there. Therefore, immediate action is necessary to ensure that this issue is rectified, and that Representative Miller-Meeks complies with House Rules, the House Ethics Manual, and Iowa voting laws.

In accordance with 18 U.S.C. § 1001, I affirm that, to the best of my knowledge and ability, all evidence submitted was not obtained in violation of any law, rule, or regulation.
